The registration for the Job's Daughters, Jungle Boogie Session was 100. The breakdown will show in the Credentials Report. We had an anonymous donor that donated \$1000.00 to cover the daughters' registration fees and \$1.00 that was deducted from each one of their meals.

After not having a Grand Bethel Session in 2020 and 2021 due to the Covid 19 Coronavirus, it was exciting to get together again. With the Miss South Dakota Job's Daughters Pageant now being held at a separate time in the fall, we were able to squeeze all the events into two days.

Sleeping room reservations were made directly with the hotel. We reserved 50 rooms in our block. Actually used: Wednesday 31, Thursday 38, Friday 32.

Wednesday night, June 8, Bethels 1, 12, & 38 hosted a reception for Aliza Goodall, GBHQ; Arianna Rice, MSDJD; and Mollie Brown, Miss SD Congeniality. The room was decorated with balloon arches and some of their favorite things. Punch and scrumptious cake and cupcakes were served.

Thursday, June 9, the Grand Council Officers began the day with setting up the Grand Bethel room. Spirit Ambassadors had their competition and winners were announced at the Formal Banquet. Meeting was called to order at 7:07pm MST by Sally Richardson.

Sally led us in an opening prayer.

The meeting was called to order by GG Julia Knutson at 10:08am with COVID protocol being followed. A quorum was established with attendance as per attached.

The opening prayer was given by Virginia Kaus, PGG.

It was moved by Sally and seconded by Sarah to table the minutes that were distributed, until after lunch to give all the opportunity to read them.

After introductions GG Julia thanked everyone for coming.

Communications included thank-you's from the 2 scholarship awardees and the reading of the obituary for Jani Lerbach. After memories were shared, it was determined to send a \$25 HIKE donation in Jani's memory. GG Julia reminded everyone to make sure the girls know they can apply for scholarship one time but any year, Freshman - advanced degree.

Reports included a tutorial by Sandy Vanneman about how to use your Bylaws and encouraged everyone, especially Line Officers, to read and study them. Our bylaws are addition or correction/substitution type of bylaws. You must begin with the Supreme version and then look at SD corrections/additions.

Also, Dawn talked about Virtual Grand. She was very disappointed with the participation and response. Sandy reminded all those that haven't yet paid their dues that they are due at the Annual Meeting for the GGC year to follow. Dues to be current for the July 2021 - June 2022 year would have been due in April 2021. A motion was made by Glen and seconded by Sally to approve the Treasurer's report.

Bethel reports:

Bethel 1 is itching to get out. Girls were thrilled with virtual Grand and liked being able to share with Bethel 38. Active girls 10-12.

Bethel 3 was able to get an Installation completed. They did a Picnic in the Park, Circus and their Honored Queen attended Conclave. Active girls 8.

Bethel 10 is struggling, and summer is especially bad. Only 2 girls participated in Grand. Active girls 4 (lost 2 to Covid). Bethel 12 is dark all summer. Active girls 7.

Bethel 21 Are still doing flags for the city on holidays. They are planning a picnic in near future. Need to evaluate their meeting dates and desperately need adults for Council. Active girls 6, 8 on the books.

Bethel 38 thought the virtual Grand was great. Installation was held and new HQ has many activities planned. Active girls 17. Will lose 4 due to majority and moving but have 3 in J2B program to join this fall with at least one other prospect.

Bethel 44 is quiet in summer and is struggling. Participated in virtual Grand with Bethel 12. Active girls 2.5 with 1 J2B to join in fall.

No additional committee reports were presented.

GG Julia reported on her activities so far. Installation was casual in Sioux Falls for those able to attend as well as viewed and participated in via zoom. GBHQ Aliza did a great job at Grand Lodge. Demolay is thriving and attending Conclave was lots of fun. The guys would like to join in some more events with the Bethels in future.

Unfinished business – Membership. It was asked if Bethel 38 had any suggestions for success with membership. Matt explained the Sundae Funday, a day to invite prospects and parents and explain what we do, as well as suggesting the Jobie to Bee program which has proven to work. Also Bethel 38 requires line officers to attend Council meetings so they can be liaison to other Bethel members and requires each girl to have an adult, preferably a parent, also attend to help girls interpret information and follow through with things line officers need to do. She is looking at November. The girls have indicated they do want to hold a pageant no matter what. Amendments last year took away a minimum for participation, however the bylaw still requires the pageant to be self-sufficient. There was discussion that if there were only 2 participants and expenses were \$1000, it would be up to the committee and the participants to cover the costs. GGC members spoke up and said if that ever happened, letting the GGC members know would certainly prompt some donations as well. Whenever pageant is scheduled make sure the girls have enough time to study and to complete Ritual Knowledge Test. If we are ever going to change the pageant from Grand to a fall date this would be the time to do so. This has been discussed to allow our Miss to have more time to make appearances and prepare, as many other states do. Concerns were brought up including if held in fall a girl would have 2 Grand Families, how many girls needed to really have a pageant and who is responsible for deciding if the pageant happens each year due to numbers and qualifications. There was further discussion about timing. A reminder to use Parker with planning. Let us know if you need her Guard schedule. Sally brought up that anyone can put their name into Supreme to compete for Miss International, however only the recognized Miss SD would get financial support and be recognized. Details of the Town Hall held by Supreme about the latest COVID protocol as distributed by Supreme was shared. Protocol for each jurisdiction should be based on the findings by John Hopkins for the past 30 days showing the percentage of infected versus population. South Dakota was at 19.52% which puts us in the red zone. Based on that we can only meet if we stay 6' apart, are masked, no marching, no singing, and no outsiders allowed. This would include outside activities as well. Percentages will put a jurisdiction in either a red, yellow or green status. To be green they would need to be under 5%. Our jurisdictional status will be posted on the web as the color we are currently at, and each Bethel will be responsible for adhering to the protocol needed. Julia will monitor the Johns Hopkins site and make any changes known to Jen to post every Sunday, and a blast will be sent via mail chimp. Every Bethel should have on file and send copies to Grand Secretary, a signed COVID acknowledgement form, no later than 12/15/21. This needs to be filled out by every member and adult. Julia will do a zoom call 12/16, assisted by Krista, to discuss these new mandates. There should be at least one person from every Bethel on the call.

Old Business - Line Officers were reminded to be reading their Constitution and Bylaws and study their responsibilities.

Communications for distribution and on website was discussed. Agreed we need both a means for mass mailing general information as well as a separate means to get information to paid GGC dues members. The website committee met with Jen and have started changes to the website to make it easier to use for promotion as well as for members. Will continue to work together.

We could be using our zoom account more to do some training and informational meetings for both members and adults. Bethels are using zoom some but could be doing more.

Julie noted Schools of Instruction are difficult virtually and none are scheduled at this time. They could be done on things other than meetings. The Grand Guardian should be talking to all the Bethels on a regular basis. Could be asking the members what they want to learn.

It was announced that 4 members have registered for Pageant. It will be held virtually with actual competition held 11/13 doing lecture, test, etc. done and recorded, and then the impromptu question and announcement of winner done live 11/20. Bethels, families of the contestants, GGC officers, Demolay and Supreme family invited to witness on 11/20. There was discussion as to how to proceed if Arianna, our Grand Sr Princess should win Miss South Dakota. Glen spoke for Arianna saying she would rather have Miss than GBHQ. Discussion centered around how to fill vacancy. Once it is known as to who wins we should not wait until

Grand to hold election, but only discuss if Arianna wins. To allow anyone interested, especially anyone not qualified or interested last spring in having their name in the bucket, it should be opened up again, with anyone qualified allowed to add their name.

New Business- The fact that there has been no fundraising done in the past few years makes it even more important to hold successful fundraising this year. Nothing has been introduced yet but Kaylene is considering 31 product or a Schwan's fundraiser. We should consider more than one. Julia and Sarah can help Kaylene with ideas and implementation. Another fundraiser mentioned was one where each person contacts 10 people and asks them to sponsor. There have been a number of youth groups who have done this with a company that directs the advertising etc. and takes a cut of proceeds. It was agreed the Schwan's fundraiser should be set up within a week. Sarah and Bobbie will look into the 10 people sponsor fundraiser.

Our Mainstay accounts/CD accounts need to be updated as far as the signatures. Currently have Dennis White, Nancy Gonsor, Dawn Erk and Toni Richardson as signatures. Names will be updated. The CD's cashed in were put into the general fund and used due to COVID restrictions. The amounts and designations for the funds have been noted and will be a part of the Mainstay Funds. If more funds are needed it makes the most sense to cash CDs than to use Mainstay funds. It was verified that the GBHQ does know how to turn in expenses but none have been turned in to date.

It was reminded that there are a number of BGC members that have not paid their GGC dues. Please make sure all have paid.

We have not received notification from Supreme about the amendments we submitted. Lyn contacted Supreme Jurisprudence and they apologized that it had fallen through the cracks. They said if all looks good they would be distributed to the committee this week and should hear from them in next week. Approved amendments will be posted.

The directory names needs updated contact info and phone numbers. Lyn sent out request to try to update Guardians and Secretaries of the Bethels to make sure upcoming Annual Report packets get out in time, and she is still missing information from some Bethels. Next year when dues are paid, a form will be required to be filled out that includes updated information.

CAV training has been clarified by Carol White. Anyone interested should contact Carol with their name and contact phone number and email. Carol will forward to Supreme and then someone from Supreme will get back to the person. Be aware it will be identified as the persons phone or email, not Supreme. They will schedule a time to virtually do class. Currently Carol does not have a current class deck to do classes, but we suggested considering a large zoom class put on by Carol for anyone in the state to take. Possibly even people wanting to refresh their information but are current. We will look into this further after first of the year.

Lyn has heard from all Bethels except #3 that they have filed their 990's with the IRS.

Minutes should be distributed within 30 days as well as attached to the agenda of upcoming meetings. Board meeting minutes should not be on the website and just mailed to Board

members. Lyn will make sure they have been printed and then they will be taken down from the website. Krista will set up a google drive to put minutes on.

The meeting was called to order by Assoc Grand Guardian Glen with Jen B, Kennedee G, Sally R, Kathryn S, Carla K, Cory K, Matt J, Gen R, Ginny K, Karen W, Andrea F, Kim M, Glen R, Krista V, Bobbie D, Audra T, Jen L, Gwen S, Carol W, Laura B, Dawn E, Kaylene S, Colleen P, Mona K, Bob C, Sarah VM, Sandy V and Lyn N present.

Glen opened the meeting in prayer.

The purpose of the meeting was to convey the information about where the GGC stands with membership after the Annual Reports were completed and to make sure everyone received the results at the same time. Since GG Julia was unable to attend, she asked G Sec Lyn to present the information.

End of year 2020 our membership was 94 members. End of 2021 our membership is 73 members. 4 Bethels have 10 or less members. If we have 70 or less members, the GGC Charter will be pulled by Supreme. The status of Reorganization must be granted new each year and runs with the term of the Grand Guardian. Per Julia she has not granted Reorganization status to any Bethel. Emergency declarations by Supreme expired 12/31/21. Bethels are required to meet twice a month or makeup the meeting. Get dispensations to move meeting dates or times from what is designated in Bethel Bylaws. COVID guidelines and protocol is now being set per state, and in South Dakota by GG Julia. Current COVID infection rate for the last month is 33.92% and hospital bed occupancy across state is 65%.

It was stated all Bethels except #38 should be put on reorganization immediately. Bethels who cannot meet 2 meetings in a row due to insufficient attendance should request a dispensation for reorganization.

Glen stated that Julia can set COVID guidelines county by county.

As a state we need to do whatever it takes to add membership. Bethels are frustrated and struggling. Our girls are in school together and doing many extra-curricular activities together already.

Glen stated we no longer need the Insurance binder fee formerly required to hold an overnight event.

It has taken a while to get the membership numbers together due to Bethel Annual Reports being mailed late, delaying discussions and future planning. Hard copies of all forms required to complete Annual Reports were mailed to every Bethel in November. There is no reason for a report to not be postmarked by 1/15/22. Some initial reports were received as late as 1/31/22. Reminders of the deadline were sent out. A \$20 late fee is owed by any late Bethel. New requirements this year by Supreme, were the 110 Addendum which was the State of the Bethel form and the Beehive report. There are no Line Officer meetings scheduled.

Numerous Bethels have people interested in doing CAV. Classes are only available online and in classes of 6. Carol should be sent the interested persons email address, address, phone number, which she passes to Supreme and is given to a trainer. The unknown trainer then contacts the adults wanting to do CAV. No identity is shown with trainers contact so people don't know who they are. Carol will talk to Mary Louise about possibility of a mass class in SD. Get a list of anyone wanting to take class to Carol White asap.

The zoom renewal will be due soon. It has been through Dawn so she will pay when it comes up and submit bill.

The Directory of names and addresses of the GGC is no longer on the website. Adults in the state need to contact one another and impossible without directory.

Councils have never received approval from Julia to be installed.

If doing COVID guidelines by county rather than by state, Julia needs to contact each Bethel individually of status.

PENDING APPROVAL

The meeting was called to order at 11:00am with the attached list of members in attendance. A quorum of all Bethels was established.

The opening prayer was given by Grand Chaplain Virginia Kaus.

The agenda was approved.

Introductions of all present were made.

Minutes of the previous meeting 3-13-22 were approved as distributed with corrections by Glen.

Communications included a list of paraphernalia that was retrieved from Bethel #13, Belle Fourche. There was a discussion of where history of SDJD should be housed going forward. Our Historian has numerous items, and they should be put somewhere where they can be accessed. A letter of concern was also read from Colleen Patmore, Bethel 21, Winner about recognizing the privacy of the Bethels and not sharing information or concerns with the general membership.

Bethel reports were as follows:

Bethel #1, Sioux Falls – They will be meeting in person next weekend for their first meeting. They have 4 active members, 4 in college, but have some prospects.

Bethel #3, Aberdeen – They are down to 4 members that come. Just finished the Circus. Have 5 prospects plus 3 more to be initiated.

Bethel #10, Pierre – They have 5 active members. The Council has met and have 3 adults pending CAV approval.

Bethel #12, Sturgis – They have 5 active members with 2 with hit and miss attendance. They meet once a month plus a fun activity. They do have a couple of prospects.

Bethel #21, Winner – They held Installation a month ago. They have 4 active members and have 4 to initiate in the fall. Their Honored Queen is a Senior and wanted to get her in before college.

Bethel #38, Sioux Falls – They have 9-12 members that come regularly. Dues have been paid by 17 members. They are meeting in person. The girls just finished with Circus. Currently have 7 prospects for Jobie to Bee and have a scavenger hunt planned downtown.

Bethel #44, Rapid City – They have 1 active member. They are having meetings in person. In process of planning a 5K Royalty Run 7/30 with and invite to attend the movies.

Grand Treasurer reported no significant changes to the Treasurer's Report since the last meeting, so none presented. All CD's have been cashed when due for renewal and put into the General Fund.

Krista reported on the Text-a-thon Fundraiser. To date \$2397.00 has been raised with more coming. It was a very simple fundraiser with 15% going to the company, and 30% going to each Bethel based on their participation. Profit from company approximately \$2100. With some of those proceeds owed to the Bethels. Comments were that the script provided needed to be tweaked somewhat. It was great to have a fundraiser that would include folks out-of-state too. There were comments from some that people didn't want any donation going to company and wanted to give directly to GGC. Also some concerned about legitimacy of fundraiser (possibly a scam), or not wanting to use a site to pay. In future include Past Grands in the contact list to give them opportunity to contribute also.

Kaylene reported on the Grand Guide Coffee Fundraiser. She didn't have numbers yet since it has just closed, however there were some orders indicated. The link for the order form had some issues. Kaylene will check on those issues. The store is still open and will be there until we close. People will be able to do reorders whenever they want, and we will still get some credit.

Krista made a presentation on a future Fundraising opportunity called "Confidence Camp", a Leadership Summit for young women. This is a program to assist with membership, legitimize our goals to educate and teach leadership skills to our members and other young women in our communities. The program "Girl Got Goals" is a program the Bethels would be able to use to hold a summit in their community and make the program as unique as they want. The mission is to be visible in the community, teach leadership skills and confidence, while promoting membership in our organization. Krista has been in touch with the CEO of the company, and she is familiar with JDI and is willing to work with us to make it our own. It does require someone to be certified in the program at a cost of \$1500 and Krista is willing to be that point person. The material will be our own and she will be able to teach it and share it to others in the state. The idea will be to offer ½ day camps through the Bethels, with materials, workshops and fun provided. Topics that could be included and are already provided in the program include confidence, how to be a leader, how to be a good friend, what to do when confronted with bullies, how to be fearless etc. Sandy made a motion that the GGC should pay for Krista to be certified and transportation costs to get camps set up for any Bethels wanting to have a camp. Toni seconded and the motion passed. Bethels indicating an interest in doing a camp were #38, #10 and possibly #3 and #21.

Grand Bethel was discussed starting with a review of the election changes that will be in place this year. There is only one girl who has submitted the required paperwork to be considered for elections for GBHQ, GBSP and BGJP. The deadline for completing Ritual of Knowledge test has been extended to 5/14. It was asked if Arianna would be able to Pro-tem as Sr. Princess for the current Grand Bethel meetings since she was elected to the office, resigned when chosen MSDJD, and the office is currently open. This would be up to GB Guardian Dawn. The schedule for Grand discussed. Wednesday night there will be a reception for GBHQ Aliza, MSDJD Arianna and Miss Congeniality Mollie at 7:30pm. Parents will provide the cake. There is no dress code if it is Jobie appropriate. Reminder that Motel reservations are due in by May 9<sup>th</sup> to get the JDI discount. No Bethels have submitted changes to the members drawn to serve the Grand Bethel for this Grand Session, so all officers are expected to be present. Formal opening will have all members in their robes, with formal dress for the Formal Dinner. The question came up as to making reservations for the motel for the Bethels requiring a credit card, which Bethels cannot have. Bethels under Supreme can use a debit card per Supreme, so Bethels under GGC would also be able to use.



The proposed budget for 2022-23 was presented for discussion by Lyn Neiman on behalf of the Finance Committee. It was a balanced budget. After some discussion Sandy made a motion to adopt the same budget as last year. Motion passed.

The Scholarship Committee received one application for Scholarship this year. The Jurisprudence Committee reported they received no Bylaw changes this year.

Sarah read the information from Angela on the HIKE Fundraiser that will run from 5/1-5/31 through Little Caesars. The information has been sent to Guardians and posted on the website.

Krista reported that despite the Pageant being held online, it was a success and the girls seemed to like having it in the Fall instead of at Grand. This also gives our Miss more time to prepare for Supreme.

Grand session was discussed, and Grand Chaplain reminded all to make sure she has the names for Necrology, of all individuals who have passed since the last in person Grand. The mold for the Amethyst pin has been found by the jeweler and we will be able to again make that award as well as the jewelry the GGC has sold in the past. Sally is working with the jeweler to make a silver version to see what it would look like, and to get pricing for solid gold, silver, and gold filled. Dawn will check into the awards from last year to make sure we have them to use this year. It was reported that the new deadline for Spirit Ambassadors to sign up will be May 11.

Unfinished Business:

CAV classes will shortly be available only online through Supreme. Sign up for classes will be done directly on the Supreme website. There will no longer be a need for a state coordinator or trainers. There will be additional education available for Required Reporters, and a refresher course for those already certified. Required Reporters would receive a certificate to turn into Supreme.

To help with communication between the GGC and Bethels Krista proposed using the Band app that Bethel #38 has had a lot of success using. Bethels #12 and #44 have tried and it didn't work for them. It was decided to go ahead and put it in place and those that want to use it can, and those who don't wouldn't have to use it.

Minutes from the Board of Trustees and the GGC will again be available on the website and emailed.

Grand Guardian, Associate Grand Guardian, Grand Guardian Council –

At your request, I have audited the books of the Grand Secretary and Grand Treasurer. I have found the financials to be in good order and in balance. Both sets of books had a beginning balance of \$10,303.65. All activity throughout the fiscal year was in balance and both sets ended the year with an ending balance of \$12,716.01.

One adjustment was made to the Grand Secretary's books to move an expense from object Grand Bethel Expense (996000) sub object Associate Grand Guardian Supreme Travel (996580) to object Grand Council Expense (992000) sub object Associate Grand Guardian Supreme Travel (996580). This was simply a housekeeping adjustment due to confusion over the chart of accounts, that seems to have listed this expense twice under two different objects.

There are a couple of issues the Grand Guardian Council should be aware of and prepare to address.

1. The computers for the Grand Secretary and Grand Treasurer are old and they are slow. They are also not using the latest version of Microsoft (Windows 11) and I'm not certain these machines are compatible to run Windows 11. Sometimes, this isn't an issue, but ....
2. The QuickBooks version 18 is outdated and unsupported. I was unable to perform any tasks within the systems, including making the mentioned adjustment above (which was made using the Grand Secretary's login – normally an unacceptable action related to an audit and the audit trail) without upgrading QuickBooks to the latest version, version 20, which requires Windows 11 to run.
3. While the two sets of books are in balance, the two sets of QuickBooks are not. This is related to a setting in QuickBooks which does not allow transactions that are older than 180 (?) days or older to be entered. Normally, this is an excellent control to avoid potential fraud or other bad acts. However, the Grand Treasurer's laptop was with the prior Auditor for an extended period of time due to Mrs. Back's health and we are unable to load those entries to get the books in balance. Further, there is a 2017 accounts receivable entry in the Grand Secretary's version that needs cleaned up. I was unable to make these adjustments because of the version upgrade issue noted in number 2 above.

At this point, the Council must determine if it is worth the expense to the Council to purchase new laptops that will run Windows 11 and whether it is worth the expense to also upgrade QuickBooks to the latest version, version 20. It may be in the best interest of the Council to explore other options that would not impose a cost or at least a minimal cost on the Council.

Sept. 29, 2019 was the last training held in SD. We currently only have 80 trained CAVs plus 4 residing out of state. Four people have recently taken the virtual training.

Virtual Training will be the only method of training from here on out. The training staff has been reduced to 16 and all of the scheduling for classes will be done on line and is up and running. To sign up for a training class go to:

[Jobsdaughtersinternational.org](http://Jobsdaughtersinternational.org), click on the sandwich menu (3 little lines) in the upper right corner, click on **Youth Protection** and then **Class Registration**. Then you may choose your class from the ones listed (be aware of time zones when you choose). Classes are 6 hours long and you must not leave the class.

There has been a problem with people not believing that they are mandatory reporters and therefore not doing their job. This section will be dropped from the actual training and become a separate Mandatory reporting class that will also be a 2 hour class done on line and a certificate will be required to be sent in.

The online renewal will continue as is for now. Eventually my position will be eliminated and everyone will be responsible for their own. For now the rules stay the same as far as getting renewals in on time. I will continue to send an email reminder to everyone at the beginning of the month 90 days in advance of the renewal date. I have also been sending a reminder at 60 days. If anyone shows up on the list of the month they are due I send a reminder but sometimes it is too late by the time I get the list so it is up to you to pay attention. You should be getting a printable card when you renew. Further down the road all of the reminders will be done automatically but that is quite a ways off.

In the future there will be a refresher course available.

GGCs, JGCs and BGCs in the United States and Canada,

The Board of Trustees is making significant changes to the training component for the Youth Protection Program. Today marks the start of a journey to streamline the CAV process and make becoming a CAV more convenient.

Our first step is to move to a full schedule of virtual training and eliminate in-person classes. This will allow flexibility for potential volunteers, no more waiting long periods of time or traveling long distances for a class. To ease this change we have deployed a new scheduler program where a class can be chosen based on the timing needs of the attendee. Each aspiring volunteer simply enrolls themselves directly into the class that makes sense for their schedule. We do recognize there may be a rare need to for an in-person class in the future and those will be handled on an exception basis.

The online class scheduler can be located on the Job's Daughters International website under the **Youth Protection** tab or directly at <https://jobsdaughtersint.corsizio.com>. Our virtual trainers are loading future classes into the tool periodically so check back often. Additionally, with this system, the YPP Regional Coordinator position is no longer needed and has been eliminated.

The next step will begin August 1<sup>st</sup> when training materials will be refreshed and the use of a professional training module on being a mandatory reporter will come into the curriculum. One of the biggest challenges over these years has been consistent training and creating up to date materials in this important area. The use of professional materials will ensure that our volunteers receive current information to fully understand their responsibilities in this area.

As we keep moving forward the plan is to eventually shift to a fully online education platform and away from 'live' trainings altogether. This goal will take some time and funding to accomplish, but it will move JDI into a more accessible set of materials for our busy volunteers.

Finally, I am announcing that our JDI YPP Coordinator, Mary Louise Gillispie will be retiring. Mary Louise has been invaluable in keeping our program on track and we wish her all the best in her retirement. The Board of Trustees has selected Stephanie Lagerman the new JDI YPP Coordinator and she will commence the duties of that role August 1<sup>st</sup>.
